



Key Dates for LCHIP Grant Round 13

Last week we sent out a [press release](#) announcing that the Board of Directors of the New Hampshire Land and Community Heritage Investment Program was opening a new round of grants for land conservation and historic preservation projects.

The Grant Round 13 application form is now available on the LCHIP website (www.lchip.org). Applicants must meet LCHIP eligibility requirements and submit a Project Registration Form on the LCHIP website. LCHIP provides matching grants, so at least 50% of the total project cost must come from sources other than the LCHIP

LCHIP Spotlight: Governor Hassan Visits LCHIP Property for Earth Day!



Governor Maggie Hassan chose to visit the LCHIP-assisted Merrimack Riverfront Reserve to celebrate Earth Day 2014. The 122 acre project in Hooksett is a joint venture between the town of Hooksett and the Society for the Protection of new Hampshire Forests, with funding assistance from both LCHIP and the Aquatic Resource management program at the Department of Environmental Services.

The Governor arrived to a sunny day and walked ten minutes through woods and muddy fields to reach the riverside. LCHIP's Dijit Taylor introduced the Governor to the assembled friends of the project. The Governor spoke about the importance of natural, cultural and historic resources to the state and presented an LCHIP sign to Steve Couture of the Hooksett Conservation Commission. Chris Wells, Senior Director for Policy and Strategic Projects at the Forest Society thanked the governor for her support of returning funding to LCHIP. The Governor concluded her visit with some additional walking through the riverfront fields that make up the property.





LCHIP Spotlight: The Belknap Mill

The Belknap Mill Society recently completed repairs to the 1823 brick textile mill's cupola, for which they received a matching grant of \$12,000 from LCHIP in 2012. During the work on the cupola, extensive decay was found in the finial that holds the gilded weathervane.

The Belknap Mill Society applied to LCHIP again in 2013 and was awarded another matching grant to rebuild the finial. Work on the finial is scheduled to be underway in Spring of 2014. [The Belknap Mill](#), situated in downtown Laconia, is the oldest unaltered textile mill in the United States and the only industrial knitting museum in the country. Aside from the museum, the building also includes a large function room available to the community plus art galleries and office space.
